RESOLUTION designating DR. HENRY C. LEE as DISTINGUISHED PROFESSOR of CRIMINOLOGY and CRIMINAL JUSTICE at CENTRAL CONNECTICUT STATE UNIVERSITY

WHEREAS, Dr. Henry C. Lee, has published his work in numerous academic journals and is held in high esteem among his peers, and
WHEREAS, Dr. Henry C. Lee's dedication to teaching is well known throughout Connecticut, the United States and the world, and
WHEREAS, Dr. Henry C. Lee has tirelessly served the Connecticut criminal justice community for more than 25 years, and
WHEREAS, Central Connecticut State University recognizes Dr. Lee's deep commitment to and profound appreciation for the democratic ideals that underlie the American system of justice, and
WHEREAS, The Department of Criminology and Criminal Justice recommends the appointment of Dr. Henry C. Lee to this distinguished professorship, and
WHEREAS, The President of Central Connecticut State University recommends that Dr. Henry C. Lee be appointed to the position of Distinguished Professor in the department of Criminology and Criminal Justice, now therefore be it
RESOLVED, That the Board of Trustees for the Connecticut State University System designates Dr. Henry C. Lee, Distinguished Professor in Criminology and Criminal Justice at Central Connecticut State University and that he retain this title throughout his appointment in accordance with all relevant sections of Article 4 of the AAUP collective bargaining agreement.

Awarding the title of Distinguished Professor of Criminology and Criminal Justice to Dr. Henry C. Lee by Central Connecticut State University

**BACKGROUND**

Pursuant to Board Resolution #2000-27, the title of Distinguished Professor may be awarded from time to time to recognize individuals of prominence who have made significant academic or otherwise valuable service to a university. The award of such a title allows a University to recognize significant contributions made to students, faculty and the university community by such individuals.

**ANALYSIS**

Dr. Henry C. Lee has provided distinguished service to the criminal justice system in the State of Connecticut and is now expected to contribute importantly to CCSU in an adjunct faculty role. In this role, it is clear that he will draw significantly on his impressive career as an internationally known criminalist and an impressive teaching and publishing record. Dr Lee is deserving of recognition for his contributions to the State of Connecticut, the United States and the world as well as his commitment to share valuable insights in a faculty role at CCSU. He is a highly appropriate candidate to be awarded the title of Distinguished Professor.

**CHANCELLOR'S RECOMMENDATION**
