RESOLUTION

concerning

Transfer of Admissions Binder to Other Constituent
Units of Connecticut System of Public Higher Education

July 13, 1973

WHEREAS, It is a primary responsibility of the Board of Trustees to act in the best interest of post-secondary students of the State, both potential and matriculated; and

WHEREAS, Many potential students make application to more than one of the institutions of public higher education in Connecticut, thereby depleting their financial assets by paying various fees and deposits; and

WHEREAS, The State College Fee is used as an Admissions Binder (non-refundable deposit) by the State Colleges; now therefore be it

RESOLVED, That the Board of Trustees hereby authorizes the transfer of the Admissions Binder (College Fee) from the Fees Fund to any other public institution of higher education in Connecticut in which the student enrolls, provided such enrollment occurs not later than sixty days after the beginning of the academic term for which the student deposited the Admissions Binder; and be it further

RESOLVED, That the College Presidents and the Executive Secretary shall establish uniform procedures for processing the transfer of the Admissions Binder to other public institutions.
