SPECIAL ACT NO. 73-109

AN ACT ENABLING THE BOARD OF TRUSTEES OF THE STATE COLLEGES TO PAY JOYCE PHIPPS.

Be it enacted by the Senate and House of Representatives in General Assembly convened:

The board of trustees of the state colleges may pay to Joyce Phipps, widow of Robert Phipps, a former professor at Southern Connecticut State College, the sum of two thousand eight hundred and seventy-four dollars and seventy-two cents, which amount represents the remaining salary of Robert Phipps 1971-1972 contract with said institution.
