

CONSORTIUM - WESTERN CONNECTICUT STATE COLLEGE AND
SOUTHERN CONNECTICUT STATE COLLEGE - SIXTH YEAR
PROGRAM IN SCHOOL ADMINISTRATION AND SUPERVISION

November 1, 1974

- WHEREAS, Western Connecticut State College has assessed the demand for a Sixth Year Program in School Administration and Supervision in the Danbury area and has found there is need for such a program, and
- WHEREAS, A cooperative arrangement with the University of Connecticut designed to provide a Sixth Year Program in School Administration and Supervision on an exploratory basis has proven to be severely limited by the factors of distance, time, traffic, and weather, and
- WHEREAS, The Sixth Year Program in School Administration and Supervision offered by Southern Connecticut State College is recognized for its quality and its practicability, could be made available on the Western Campus, except for the final seminar which would be held at Southern Connecticut State College, through a consortium involving the two colleges, and
- WHEREAS, The Commission for Higher Education has encouraged consortium arrangements as a means of avoiding the duplication of effort and cost, therefore, be it
- RESOLVED, That the Board of Trustees, acting within its statutory authority (Section 10-109b of the General Statutes) subject to approval by the Commission for Higher Education, hereby authorizes a consortium between Western Connecticut State College and Southern Connecticut State College through which the Sixth Year Program in School Administration and Supervision will be offered by Southern Connecticut State College on the campus of Western Connecticut State College.

SUBJECT: Cooperative arrangements for the presentation of a sixth-year program in Administration and Supervision

To confirm our discussion of this date, the Administration and Supervision Department of Southern Connecticut State College has agreed to present its sixth-year degree program on the Western Connecticut State College campus with the following cooperative arrangement:

1. Recruiting and screening of potential students will be handled by personnel at WCSC. Those recommended by the WCSC Director of Teacher Education will then be processed in the same manner as other SCSC students. Upon completion of this procedure, they will be enrolled as graduate students at SCSC and will receive instruction by regular SCSC faculty of the Administration and Supervision Department.
2. Upon completion of courses Adm. 681-685 inclusive, students meeting other state requirements (i.e. five years of teaching experience including at least three in public schools and possessing the State Standard Teaching Certificate) will be recommended for the Provisional Intermediate Certificate as an Administrator and Supervisor.
3. In completing requirements for the Professional Diploma of Advanced Study, students may take nine credit hours of cognate courses (relevant to their professional goals) selected from the WCSC Division of Graduate Studies catalog.
4. Faculty at WCSC will supervise Adm. 688 Field Experience and Study in cooperation with local school systems and under guidelines mutually agreed to with the Administration and Supervision Department at SCSC.
5. Adm. 689, Seminar in Administration (the culminating course in the sixth-year program) will be presented on the SCSC campus each fall and spring semester. Students successfully completing this course will be eligible for graduation from SCSC.
6. Payment for courses presented by SCSC faculty will be made to SCSC. Payment for courses presented by WCSC faculty will be made to WCSC and credits will be transferred to SCSC in the usual manner.

7. Adm. 681 (the first course in the sequence) will be offered at WCSC in the spring semester of 1975. In the fall of 1975, Adm. 682 will be offered to those same students and a new section of Adm. 681 will be presented if sufficient students are available to begin a new "cluster." Class size should be approximately 20-24 with 25 the maximum.
8. When the program is fully developed, SCSC faculty will offer five courses (one section each of Adm. 681-685 inclusive) in the fall and spring semesters. Summer school offerings will be limited to the presentation of electives by WCSC faculty. Such electives may also be taken concurrently with core courses in the fall or spring with permission of the Director of Teacher Education and/or the Dean of Graduate Studies at WCSC.

Adm. 688 and 689 will be offered in the Spring and Fall only.
9. Scheduling of days, hours and rooms will be worked out cooperatively.
10. Announcements of the new program will be made by WCSC and circulated in Western Connecticut and New York state.

Such announcements should be checked in advance with the SCSC Department of Administration and Supervision to insure accuracy.

Position Paper

6th Year Program in Administration and Supervision

"Many educators and officials in the State of Connecticut have become increasingly concerned about the duplication of program efforts in our higher educational institutions." ¹

The 6th Year Program in Administration and Supervision at Southern Connecticut State College is a well established one; one that is recognized for both its quality and its practicability. We, at Western Connecticut State College, would like to form a consortium with our sister institution as encouraged by the Commission for Higher Education and the Board of Trustees of the State Colleges; to bring to our clientele the advantages offered by the Administration and Supervision Program of Southern Connecticut State College. W.C.S.C. officials are agreeable and the S.C.S.C. officials are agreeable to establishing such a consortium. The response from our student body has been overwhelming and most favorable. It is important to accommodate the needs of our community if we are to fulfill the mission of our college as stated by our Board of Trustees. The Administration and Supervision Program of Southern Connecticut State College will be adopted in toto. All the courses, except the final seminar will be given on the campus of Western Connecticut State College. At least six of the ten courses will be taught by the faculty from Southern Connecticut State College.

While the University of Connecticut offers a "similar" arrangement for our institution; at least 5 courses of the 10 courses required, must be taken at the Storrs, Connecticut campus: Storrs is not a short distance from the Danbury area. The arrangements for our clientele have not been altogether satisfactory under this consortium as distance, time, traffic and weather have caused some concern to the members of our community.

We, at Western Connecticut State College, suggest that to avoid additional costs to the taxpayers of Connecticut, that the 6th Year Program in Administration and Supervision of Southern Connecticut State College be offered on the campus of Western Connecticut State College.


A student from our geographical area going to one of the private institutions offering this program would have to pay increased tuition costs, increased travel costs, increased energy consumption costs for a program that can at best be "equal" to the one offered by Southern Connecticut State College on the campus of Western Connecticut State College.

Coordination of the Program in Administration and Supervision between S.C.S.C. and W.C.S.C. is totally resolved and commitments to each other mutually agreeable.

It would appear that the citizens of Connecticut would be the losers, if the program in Administration and Supervision were to be stymied by the self interests of partisan groups, wherever they may abide.

Therefore: The administration of Western Connecticut State College recommends that the Planning Committee of the Board of Trustees of the Connecticut State Colleges approve the arrangements for a consortium for the 6th Year Program in Administration and Supervision, between Southern Connecticut State College and Western Connecticut State College.


