

SIXTY-TWO YEARS OF AGE OR OLDER

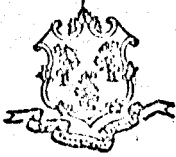

- WHEREAS, It was the apparent intent of Public Act 74-282 to provide persons sixty-two years of age or older with educational opportunities at the lowest possible cost; and
- WHEREAS, The Trustees enacted Resolution number 74-52, dated July 19, 1974, to carry out the mandate of Public Act 74-282; and
- WHEREAS, In furthering the intent of the law, it is the desire of the Trustees to exempt persons sixty-two years of age or older from the payment of the State College Fee and of Educational Extension Program course fees; therefore be it
- RESOLVED, That, as applicable, neither the State College Fee nor Educational Extension Program course fees shall be charged to any person sixty-two years of age or older who has been accepted for admission to a State College, provided such person is enrolled in a degree granting program or, if not enrolled in a degree granting program, provided at the end of the regular registration period there is space available in a course or courses in which such person intends to enroll; and be it
- RESOLVED, That the effective date of the provisions of this resolution is the first day of the 1974 Fall semester.



WAIVER OF TUITION FEES FOR PERSONS

SIXTY-TWO YEARS OF AGE OR OLDER

July 19, 1974

WHEREAS, Public Act #74-282 mandates that the Board of Trustees for State Colleges waive the payment of tuition fees at the State Colleges:

...for any person sixty-two years of age or older, who has been accepted for admission to such institution, provided such person is enrolled in a degree granting program or, provided, at the end of the regular registration period, there is space available in the course in which such person intends to enroll....,

THEREFORE
BE IT
RESOLVED,

That, the Board of Trustees for the State Colleges authorizes the waiver of tuition for persons sixty-two years of age or older as stipulated above, beginning in the Fall semester of 1974, subject to the approval of the Commission for Higher Education.

PRESIDENTS' COUNCIL
RECOMMENDED

Procedure for Waiver of Tuition for the Elderly (Public Act No. 74-282)

1. Proof of age must be submitted at time of registration.
2. Enrollees in a degree granting program shall be registered during the normal period of registration for day college courses but for Educational Extension courses registration shall be at the end of the regular registration period, provided there is space available in such courses.
3. Enrollees not in a degree granting program wishing to register for one or more courses shall be registered at the end of the regular registration period, provided there is space available in such course or courses.
 - 3.1 The established class size has not been exceeded.
 - 3.2 The registration of persons over sixty-two years of age will not count toward meeting minimum class size required for offering the course.
4. The General Fee and Student Activity Fee are not waived.
5. State College Fee to be waived.

Sec. 10-115h. Enforcement of regulations. The board is authorized to make and enforce regulations to govern the operations of the state colleges and the foundation in accordance with the provisions of sections 10-115b to 10-115i, inclusive.

Sec. 10-115i. Rights as to products of authorship. The provisions of sections 10-115b to 10-115i, inclusive, shall not entitle the state colleges or the foundation to claim any literary, artistic, musical or other product of authorship covered by actual or potential copyright under the laws of the United States; but the state colleges and the foundation shall each be authorized to make and enforce any contract, express or implied, which they may make with reference to any such subject matter.

Sec. 10-116. Tuition. Fees. Refunds. Waivers. (a) Subject to the provisions of section 10-329b, the board of trustees of the state colleges shall fix fees for tuition of not less than three hundred ninety dollars for residents of this state and not less than one thousand thirty dollars for nonresidents and shall fix fees for such other purposes as the board deems necessary at the state colleges, subject to the approval of the board of higher education, and may make refunds of the same, and any amount by which the tuition paid by any resident pursuant to this section exceeds three hundred dollars and any amount by which the tuition paid by any nonresident exceeds eight hundred fifty dollars shall be included in the appropriations to the constituent unit known as the state colleges and shall be used solely for educational purposes at said constituent unit.

(b) Said board shall waive the payment of tuition fees at any of the state colleges (1) for any dependent child of a person whom the armed forces of the United States has declared to be missing in action or to have been a prisoner of war while serving in such armed forces after January 1, 1960, which child has been accepted for admission to such institution, provided such person missing in action or former prisoner of war was a resident of Connecticut at the time he entered the service of the armed forces of the United States or was a resident of Connecticut while so serving, (2) for any veteran having served in time of war, as defined in subsection (a) of section 27-103, who has been accepted for admission to such institution, provided such veteran was a resident of Connecticut at the time he entered the service of the armed forces of the United States or was a resident of Connecticut while so serving and is a resident of Connecticut at the time he is accepted for admission to such institution, (3) for any person sixty-two years of age or older who has been accepted for admission to such institution, provided such person is enrolled in a degree granting program or, provided, at the end of the regular registration period, there is space available in the course in which such person intends to enroll, and (4) for any student attending the Connecticut police academy who is enrolled in a law enforcement program at said academy offered in coordination with a state college which accredits courses taken in such program.

(c) Said board may waive or remit the tuition at any of the state colleges for any person who has been accepted for admission to such institution and who demonstrates substantial financial need, provided the tuition of not more than ten

Procedure for Waiver of Tuition for the Elderly (Public Act No. 74-282)

1. Proof of age must be submitted at time of registration.

 - 2.1 The established class size has not been exceeded.
 - 2.2 The registration of persons over sixty-two years of age will not count toward meeting minimum class size required for offering the course.
3. The General Fee and Student Activity Fee are not waived.
4. State College Fee to be waived.
