### RESOLUTION

concerning

THE TRANSFER OF FUNDS AND POSITIONS FROM SOUTHERN  
CONNECTICUT STATE COLLEGE TO CENTRAL CONNECTICUT STATE COLLEGE

November 7, 1975

- WHEREAS, The division of 1975-1976 General Fund appropriations, which was approved by the Board of Trustees on June 13, 1976<sup>5</sup>, was, to a large extent, based on the ratios of budgeted enrollments of the State Colleges, and
- WHEREAS, The actual enrollment at Central Connecticut State College has exceeded the budgeted number by 171 students and the actual enrollment at Southern Connecticut State College has fallen short of the budgeted number by 263 students, and
- WHEREAS, The Trustees believe that a transfer of funds and positions from Southern Connecticut State College to Central Connecticut State College would aid in achieving parity between the faculties of the two colleges, be it
- RESOLVED, That, effective January 1, 1976, there shall be transferred from Southern Connecticut State College to Central Connecticut State College three unclassified positions and there shall be an adjustment in the original division of General Fund appropriations whereby the Personal Services allocation is reduced for Southern Connecticut State College and increased for Central Connecticut State College in the amount of \$25,894.
