

This will confirm our telephone conversation of January 23, 1976.

Enclosed is a copy of a memorandum dated January 21, 1976 to the undersigned from Dr. C. A. Clow, Executive Officer for Finance and Management of the Board of Trustees for the State Colleges.

This memorandum indicates that the bill for 1973-74 will be paid within two weeks and the bill for 1974-75 will be paid in about one month.

The amount covering the years 1969-70, 1970-71 and 1971-72, which totals approximately \$460,000.00 is long overdue. This office has been requested by the Board of Trustees for State Colleges to take whatever action is necessary to effect collection.

Please communicate to me, in the near future, the position of the New Britain Board of Education with respect to the \$460,000.00. Hopefully, your client will agree to pay this amount with dispatch, so that a law

A meeting was held on January 20, 1976 with the City of New Britain officials to discuss the subject named problem. Mr. Thomas Doyle, City of New Britain Director of Finance, has agreed to the following:

1. Payment of 1973-74 bill of approximately \$366,120.00.

Payment to be made within the next two weeks. This time is required for necessary paperwork.

2. Payment of 1974-75 bill of approximately \$301,819.00.

This payment will be made near the end of February since Mr. Doyle must wait for final figures from the City of New Britain's Board of Education.

3. An amount of approximately \$460,000.00 covering the years 1969-70, 1970-71, and 1971-72 is still outstanding.

We request that you contact the Corporate Counsel of the City of New Britain to discuss the City of New Britain's position relative to this amount.


