
I wish to apply for the position of Dean of the School of Business and Public Administration at Western Connecticut State College.

Joined Hofstra as an instructor in September 1969; promoted to assistant professor in September 1970; appointed Department Chairman in September 1973; promoted to associate professor in September 1974. In addition to my regular duties as Chairman, I have undertaken the following:

- Served on President's Budget Committee, and currently serving as special advisor to the University Provost on budgetary affairs and problems.
- Work with the University's Admissions Office in the recruitment of qualified students for enrollment. Work includes visits to and guest speaking at secondary schools and junior colleges in the northeast.
