
WHEREAS, There is no Board of Trustees' policy covering the initial appointment to unclassified positions of current state employees serving in Connecticut State College classified positions, and

WHEREAS, The state policy is clear as to the continuing rights of former classified employees when accepting an appointment to an unclassified position, therefore be it

RESOLVED, That any classified State College employee reclassified into an unclassified State College position shall be appointed to such position in accordance with the contract in effect for that unclassified position, and be it further

RESOLVED, In cases of such reclassification, nothing is intended by this policy to deny classified employees who are reclassified any rights earned and retained under conditions of previous state employment and as stipulated in state policy or negotiated agreements effective at the time of reclassification.

RESOLVED, That all appointments to the unclassified service in the Connecticut State Colleges, including reclassification of current classified State College employees, shall be regarded as initial appointments in accordance with Article 4.7 of the AAUP Contract and Article X of the AFSCME Contract, and be it further

RESOLVED, In cases of such reclassification, nothing is intended by this policy to deny classified employees who are reclassified the rights earned and retained under conditions of previous state employment and as stipulated in state policy or negotiated agreements effective at the time of reclassification.
