RESOLUTION

concerning

DR. CARL L. ROBINSON

January 12, 1979

- WHEREAS, Under the terms of Board Resolution #78-69, dated July 14, 1978, Dr. Carl L. Robinson, Vice President for Administrative Affairs at Western Connecticut State College, has served faithfully as Acting Executive Officer for Finance and Management during the illness of Mr. Frederic W. Rossomando who is the Executive Officer for Finance and Management, and
- WHEREAS, Mr. Rossomando has now been returned to good health and has resumed his regular duties, and
- WHEREAS, During the period of Mr. Rossomando's absence, Dr. Robinson developed the General Fund Budget Request for 1979-1980 and engaged in certain studies of concern to the Office of Finance and Management and, hence, to all the Connecticut State Colleges, therefore, be it
- RESOLVED, That effective this date Dr. Robinson is relieved of his assignment as Acting Executive Officer for Finance and Management and Mr. Rossomando is restored to responsibility for that office; however, be it
- RESOLVED, That Dr. Robinson shall continue on part-time assignment to the Executive Staff until July 1, 1979, and that in this capacity he shall continue to have responsibility for the 1979-1980 General Fund Budget Request and shall carry out such other assignments as may be made by the Executive Director, and be it
- RESOLVED, That during his part-time assignment to the Executive Staff, Dr. Robinson shall retain his title and authority as Vice President for Administration at Western Connecticut State College, and that Western Connecticut State College shall remain his duty station, and be it
- RESOLVED, That during his part-time assignment to the Executive Staff Dr. Robinson's salary of \$34,551 shall be increased on an annual basis by \$4,000, and be it
- RESOLVED, That the President of Central Connecticut State College is requested to provide Dr. Robinson a guest room in the College Residences for his use without charge during the period of his part-time assignment to the Executive Staff.

- WHEREAS, The illness of Mr. Frederic Rossomando has left the Office of Finance and Management without leadership, and
- WHEREAS, After consultation with President Bersi, Dr. Frost has recommended that Dr. Carl L. Robinson, Vice President for Administrative Affairs at Western Connecticut State College, be appointed Acting Executive Officer for Finance and Management while retaining his title and office at Western Connecticut State College; therefore, be it
- RESOLVED, That Dr. Carl L. Robinson be and hereby is appointed Acting Executive Officer for Finance and Management to serve until such time as Mr. Rossomando returns to take up his duties, and be it
- RESOLVED, That during his tenure as Acting Executive Officer for Finance and Management, Dr. Robinson shall retain his title and authority as Vice President for Administration at Western Connecticut State College, and that Western Connecticut State College shall remain his duty station, and be it
- RESOLVED, That during his tenure as Acting Executive Officer for Finance and Management Dr. Robinson's salary of \$34,551 be increased on an annual basis by \$4,000, and be it
- RESOLVED, That the President of Central Connecticut State College is requested to provide Dr. Robinson a guest room in the College Residences for his use without charge during Dr. Robinson's tenure as Acting Executive Officer for Finance and Management.
