REQUEST FOR VOLUNTARY CHECKOFF PRIVILEGES for CONNECTICUT PUBLIC INTEREST RESEARCH GROUP at CENTRAL CONNECTICUT STATE COLLEGE

April 6, 1979

WHEREAS, The administration of Central Connecticut State College has been requested by student members of the campus chapter of the Connecticut Public Interest Research Group (CONNPIRG), an officially recognized student group, to authorize a voluntary checkoff fee on the college fee bill as a means of raising funds, and


WHEREAS, Monies collected by the voluntary checkoff mechanism will be controlled by the Central Connecticut State College Chapter of the Connecticut Public Interest Research Group (CONNPIRG), subject to the regulations governing student activity funds, now therefore, be it

RESOLVED, That if the Central Connecticut State College Chapter of the Connecticut Public Interest Research Group (CONNPIRG) presents to the President of that campus a petition containing the valid signatures of five (5) percent of the full-time matriculated students of that campus, the President shall cause a referendum to be conducted among all full-time, matriculated students on the question: Shall the Central Connecticut State College Chapter of the Connecticut Public Interest Research Group (CONNPIRG) be recommended to the Trustees for the privilege of including a voluntary checkoff fee of \$2 on the College fee bill?, and be it further

RESOLVED, That if a minimum of twenty (20) percent of the full-time matriculated students participate in the referendum and if a majority of those participating recommend in the affirmative, the President of Central Connecticut State College shall submit this student recommendation to the Trustees together with the following:

1. His certification that the organization recommended for voluntary checkoff privileges is an officially recognized student organization at his campus,
2. His assessment of the educational value for students of the organizations proposed activities, and
3. His personal recommendation, based on the above and any other pertinent factors, whether or not the voluntary checkoff privilege should be extended to the organization.

As the certifying official at Central Connecticut State College, I respectfully submit the following to be the official results of the CCSC Student Government Association balloting on April 25 and April 26, 1979 concerning a referendum question which read:

"Motion to allow Connecticut Public Interest Research Group (CONNPIRG) to become an optional checkoff funded organization from the Student Fees."
A=YES (556) B=NO (212)

With an enrollment of 5876 students and 768 students (13% of FTE) participating in the referendum it appears that the required minimum of 20% of FTE was not realized.
