

TEMPORARY AUTHORIZATION FOR EXTENSION OF PAST PRACTICES
in
REMUNERATION FOR RESIDENT ASSISTANTS AND ASSISTANT DORMITORY DIRECTORS

March 7, 1980

- WHEREAS, Illnesses and changes of personnel have resulted in failure to comply with Board Resolution #77-40, dated May 6, 1977, therefore, be it
- RESOLVED, That Resolution #77-40 is repealed, and be it
- RESOLVED, That effective with the academic year 1977-1978 each of the Connecticut State Colleges is authorized to continue the pattern of residence hall staffing as it existed during the academic year 1976-1977 and to continue the related remuneration plan as altered by the terms of collective bargaining contracts, subject to such modifications as the College President may make without added cost for personal services, and be it
- RESOLVED, That the Executive Director, in consultation with the College Presidents, shall develop and propose to the Budget Committee and the Personnel Committee of the Board of Trustees policies for residence hall staffing patterns and related costs.

TEMPORARY AUTHORIZATION FOR EXTENSION OF PAST PRACTICES

REMUNERATION FOR RESIDENT ASSISTANTS AND ASSISTANT DORMITORY DIRECTORS

May 6, 1977

- WHEREAS, Remuneration for the services of Resident Assistants and Assistant Dormitory Directors has for many years included the waiver of room and board fees, and in some cases, the payment of a small stipend, and
- WHEREAS, This practice, although of long standing, is not specifically authorized by Board Resolution, and
- WHEREAS, The Board of Trustees desires a policy review including a cost analysis and possible policy formation, and
- WHEREAS, A cost analysis of residence halls operation has now been made but has not yet been reduced to staffing and cost policies, and
- WHEREAS, The Trustees wish to avoid a disruption of staffing arrangements for the academic year 1977-1978, therefore, be it
- RESOLVED, That the Trustees hereby authorize, for the 1977-1978 academic year only, the continuation by each Connecticut State College of its present pattern of residence hall staffing and related remuneration plan as altered by the terms of collective bargaining contracts, subject to such modifications as the College President may make without added cost for personal services, and be it
- RESOLVED, That the Executive Director, in consultation with the College Presidents, shall propose to the Budget Committee and the Personnel Committee of the Board of Trustees policies for residence hall staffing patterns and related costs to be put into effect for the 1978-1979 academic year.



TEMPORARY AUTHORIZATION FOR EXTENSION OF PAST PRACTICES
in
REMUNERATION FOR RESIDENT ASSISTANTS AND ASSISTANT DORMITORY DIRECTORS

October 1, 1976

- WHEREAS, Remuneration for the services of Resident Assistant and Assistant Dormitory Directors has for many years included the waiver of room and board fees, and in some cases, the payment of a small stipend, and
- WHEREAS, This practice, although of long standing, is not specifically authorized by Board resolution, and
- WHEREAS, The Board of Trustees desires a policy review including a cost analysis and possible policy formation but does not wish to disrupt staffing arrangements for the current academic year, therefore, be it
- RESOLVED, That the Board of Trustees hereby authorizes, for the 1976-1977 academic year only, the continuation by each State College of the remuneration plan for residence hall staff currently in effect at that College, and be it
- RESOLVED, That the Executive Director and the College Presidents are hereby directed to study the matter, giving particular regard to cost and the propriety of policy, and to provide their corporate recommendations to the Board of Trustees not later than the February, 1977 Meeting of the Board.
