RESOLVED, That, during his tenure as Acting Executive Officer for Faculty and Staff Affairs, Dr. Jestin shall continue to serve as Vice President for Academic Affairs at Central Connecticut State College; and be it

RESOLVED, That, during the period Dr. Jestin serves in a dual capacity as Vice President for Academic Affairs and as Acting Executive Officer for Faculty and Staff Affairs, his salary as Vice President shall be augmented by \$4,045.50 per year on an annual basis or \$155 biweekly.
