

January 9, 1981

- WHEREAS, The Trustees in Resolution 80-26 dated March 7, 1980, granted approval for an exchange of professors between Central Connecticut State College and Ilkley College in England, and
- WHEREAS, Under the terms of the said Resolution Professor Frederic Warner of Central Connecticut State College was to teach at Ilkley College and Mr. Alan Lumb of Ilkley College was to teach courses at Central Connecticut State College, this exchange to take place during the Academic Year 1980-1981, and
- WHEREAS, Dr. Warner finds it necessary to terminate his work at Ilkley College, therefore be it
- RESOLVED, That, during the second semester of the current academic year, Professor Norma Smith of Central Connecticut State College shall replace Dr. Warner as the exchange professor at Ilkley College; that the salary of Dr. Smith shall be paid by Central Connecticut State College; that the costs of transportation, lodging and other personal expenses incurred by Dr. Smith as a result of this exchange shall be fully assumed by Dr. Smith, and be it
- RESOLVED, That Dr. Warner shall return to Central Connecticut State College at the beginning of the second semester of the current academic year and shall take up his responsibilities as a member of the faculty, and be it
- RESOLVED, That except for the amendments made by the adoption of this Resolution on January 9, 1981, the conditions stated in Resolution 80-26, dated March 7, 1980, shall continue in force.

WHEREAS, An exchange of teachers with foreign institutions provides enrichment of educational programs, be it

RESOLVED, That under the authority granted by Sections 10-27, 10-109b and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorizes an exchange of teachers involving Dr. Frederic Warner, Professor of Anthropology at Central Connecticut State College, and Mr. Alan Lumb, Lecturer in the Department of Community Studies at Ilkley College, in Ilkley, England. The said exchange to be subject to the following conditions:

- A. The salary of Dr. Frederic Warner shall be paid by Central Connecticut State College.
- B. The salary of Mr. Lumb shall be paid by Ilkley College.
- C. Transportation, lodging, and other personal expense incurred in the exchange will be fully assumed by the individuals involved.
- D. Mr. Lumb will report to the Acting Chairman of the Department of Sociology-Anthropology of Central Connecticut State College at the beginning of the Fall Semester 1980, and will assume Dr. Warner's teaching assignments, including teaching up to six semester hours in the Extension College.
- E. The exchange shall be for the 1980-81 academic year.

WHEREAS,

Professor Frederic Warner received approval for an exchange professorship at Ilkley College in England by Board resolution on March 7, 1980, and because Professor Warner finds it necessary for personal reasons to terminate his exchange at Ilkley, it has been recommended by appropriate academic officers at Central that Professor Norma Smith be afforded the opportunity to participate in the exchange program with Ilkley College for the 1981 Spring Semester.

RESOLVED,

That under the authority granted by Sections 10-27, 10-109b and 10-329a of the General Statutes, the Board of Trustees for the State Colleges of Connecticut authorizes an exchange of teachers involving Dr. Norma Smith, Professor of Education at Central Connecticut State College, and Mr. Alan Lumb, Lecturer in the Department of Community Studies at Ilkley College in Ilkley England. The said exchange to be subject to the following conditions:

- A. The salary of Dr. Norma Smith shall be paid by Central Connecticut State College.
- B. The salary of Mr. Lumb shall be paid by Ilkley College.
- C. Transportation, lodging, and other personal expense incurred in the exchange will be fully assumed by the individuals involved.
- D. Mr. Lumb will report to the Chairman of the Department of Sociology-Anthropology of Central during the Spring Semester, 1981.
