- WHEREAS, There will be a vacancy in the academic vice presidency at Eastern Connecticut State College as of February 19, 1981, and
- WHEREAS, M. Kathleen McGrory has distinguished herself in the position of Dean of Arts and Sciences at Eastern Connecticut State College and, in a variety of capacities over the past twelve years, has brought honor and distinction to the Connecticut State Colleges through her teaching, scholarship, and administrative competence, and
- WHEREAS, Faculty and staff support for Dr. McGrory has been overwhelmingly and tangibly demonstrated, and
- WHEREAS, The President of Eastern Connecticut State College endorses these expressions of campus sentiment and, having complete confidence in her administrative and human qualities, recommends the promotion of Dean McGrory to the position of Vice-President for Academic Affairs, now; be it
- RESOLVED, That Dr. M. Kathleen McGrory be and hereby is appointed Vice-President for Academic Affairs at Eastern Connecticut State College at the annual salary of \$39,500 effective February 20, 1981.
