RESOLUTION

concerning

AN INCREASE IN UNIVERSITY GENERAL FEE

January 6, 1984

WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University, subject to the approval of the Board of Governors for Higher Education, shall fix fees for such purposes as the Board of Trustees deems necessary, and

WHEREAS, Revenue produced at current rates is not sufficient to cover escalating costs due to inflation, increased rates for fuel and utilities, and salary adjustments, be it


RESOLVED, That, if the Board of Governors for Higher Education concurs, the State University General Fee per academic year shall be changed as follows, effective for the Fall Semester 1984:


