## RESOLUTION

concerning

### ALCOHOLIC BEVERAGES ON THE CAMPUSES OF THE CONNECTICUT STATE UNIVERSITY

February 3, 1984

- WHEREAS, By resolution of November 3, 1972, the Board of Trustees permitted possession and consumption of alcohol on the Connecticut State University campuses under conditions established by the authorities of each campus, and
- WHEREAS, By act of the Connecticut General Assembly as approved by the Governor and incorporated in the General Statutes in Section 30-20a sale of beer and wine was permitted on Connecticut State University campuses, and
- WHEREAS, By act of the Connecticut General Assembly as approved by the Governor in Public Act 83-508 the legal drinking age was determined to be 20 years of age, therefore, be it
- RESOLVED, That Trustees Resolution 72-30 is repealed, and be it further
- RESOLVED, That the sale of alcoholic beverages and the possession and consumption of alcoholic beverages shall be permitted on the campuses of the Connecticut State University in accordance with state law and regulations and within the conditions established by the authorities of each campus.

## RESOLUTION

regarding

Consumption of Alcoholic  
Beverages  
on the

Connecticut State College Campuses

November 3, 1972

WHEREAS, Public Act #127 enacted by the 1972 General Assembly granted full rights and privileges to eighteen-year olds, and

WHEREAS, the Presidents of the State Colleges, together with the members of the Student Advisory Board, have considered the development of regulations within which students could enjoy alcoholic beverages on the campuses and have made certain recommendations related thereto,

THEREFORE BE IT RESOLVED, that the Board of Trustees for State Colleges pursuant to its authority vested in Section 10-109b of the General Statutes, hereby approves the recommendations of the Presidents and the Student Advisory Board and permits within the conditions to be established by each individual college, the possession and consumption of alcoholic beverages on the State College campuses.

BE IT FURTHER RESOLVED, that the Board of Trustees hereby requests the Executive Secretary to explore the possibility of legislation to be submitted to the 1973 General Assembly which will enable the sale of alcoholic beverages on the State College campuses.
