RESOLUTION

concerning

ESTABLISHMENT OF A TRANSFER CREDIT REVIEW BOARD

December 3, 1976

WHEREAS, In Resolution #72-1 dated December 13, 1972 the Trustees established a policy to accept, under certain conditions, graduates of the college transfer programs at the Regional Community Colleges, and

WHEREAS, In some instances students have felt they were not given adequate credit upon admission to the Connecticut State Colleges, therefore be it

RESOLVED, That, if the Board of Trustees of the Regional Community Colleges concur, there be established a Transfer Credit Review Board composed of three persons appointed by the Executive Director for the Regional Community Colleges and three persons appointed by the Executive Director of the Connecticut State Colleges, and be it

RESOLVED, That the chairperson of the Transfer Credit Review Board hold office from September first of each year through the following August thirty-first and that in September of the odd numbered years the chairperson be named by the Executive Director for the Regional Community Colleges and that in September of the even numbered years the chairperson be named by the Executive Director for the Connecticut State Colleges, and be it

RESOLVED, That whenever a student at a Regional Community College has concern over the transfer of credits to a Connecticut State College he or she shall go first to the Counselor designated by his or her Regional Community College to deal with such problems and the Counselor shall contact the appropriate persons at the Connecticut State College to which the student seeks transfer or admissions, and be it

RESOLVED, That should the Counselor be unable to settle the matter in a manner deemed proper by the student, then and only then may the case be referred to the Transfer Credit Review Board, and be it

RESOLVED, That the Transfer Credit Review Board is authorized to communicate directly with the campuses involved in an effort to settle the matter in an equitable manner; however, should the Transfer Credit Review Board be unable to bring about an equitable solution it shall make a report of its findings and its recommendations to both Executive Directors at the same time sending a copy of the report to the Presidents of the colleges involved.

1. ACADEMIC POLICY

- 1.8 <u>Transfer Credit Review Board: Regional Community Colleges and the Connecticut State University.</u>
 - 1.8.1 The Transfer Credit Review Board is composed of three persons appointed by the Executive Director for the Regional Community Colleges and three persons appointed by the President of the Connecticut State University.
 - 1.8.2 The Chairperson of the Transfer Credit Review Board holds office from September first of each year through the following August thirty-first. In September of the odd numbered years the chairperson is named by the Executive Director for the Regional Community Colleges and in September of the even numbered years the chairperson is named by the President of the Connecticut State University.
 - 1.8.3 Whenever a student at a Regional Community College has concern over the transfer of credits to a Connecticut State University he or she goes first to the Counselor designated by his or her Regional Community College to deal with such problems and the Counselor contacts the appropriate persons at the Connecticut State University to which the student seeks transfer or admission. Should the Counselor be unable to settle the matter in a manner deemed proper by the student, then and only then is the case referred to the Transfer Credit Review Board.
 - 1.8.4 The Transfer Credit Review Board is authorized to communicate directly with the campuses involved in an effort to settle the matter in an equitable manner; however, if the Transfer Credit Review Board is unable to bring about an equitable solution it makes a report of its findings and its recommendations to the R.C.C. Executive Director and, at the same time, sends a copy of the report to the President of the University involved.
