


This information should be used for reference only by Central Connecticut State, as most times costs vary due to individual site installation circumstances. However, a commercial installation similar to yours at Central Connecticut would cost approximately \$87,750 for initial purchase and first year's maintenance, with an annual renewal fee of \$17,550 for every year thereafter.

As you can see, the software donation we are making to Central Connecticut State University is an extremely valuable one. On the other hand, the education of future business leaders is also very valuable, and is most assuredly an ongoing resource for commercial clients using our software.
