

FEE INCREASES FOR CONNECTICUT STATE UNIVERSITY STUDENTS
TIER I

February 4, 1994

- WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, Goodwin, Loomis, and Britton, Inc., after review of the CSU Insurance Programs claim experience, notified CSU that an increase of 12% would be required for FY1994-95 for both the accident and sickness fees, therefore be it
- RESOLVED, That the President of Connecticut State University is authorized to contract with Goodwin, Loomis, and Britton, Inc., as agent for CIGNA, for mandatory student accident insurance (component of the University General Fee) and mandatory student sickness insurance, and be it further
- RESOLVED, That Board Resolution 93-2 is rescinded and the fee for mandatory sickness insurance coverage for all full-time students, except for international students on J-1 Visas, for the academic year 1994-95 shall be \$271.00 per year with a Fall semester payment of \$108.00 and a Spring semester payment of \$163.00, and be it further
- RESOLVED, That the University General Fee for academic year 1994-95 at each university shall be increased by \$8.00 to cover the mandatory accident insurance program costs of \$77.50 per year for all full-time students, except for international students on J-1 Visas, and be it further
- RESOLVED, That the mandatory sickness insurance fee may be waived if a full-time student provides a properly executed university waiver form which attests to the fact that the student has adequate sickness insurance coverage from an insurance carrier licensed to operate in the United States, with the identification of the carrier and the policy number of the alternative insurance signed by the student or by a parent or legal guardian, if the student is a minor, and be it further
- RESOLVED, That Board Resolution 93-87 is amended and effective for FY 1994-95, and the rates shown on the attached schedules shall be charged at each campus as appropriate.
