

FEE INCREASES FOR CONNECTICUT STATE UNIVERSITY STUDENTS  
TIER I

May 6, 1994

- WHEREAS, Section 10a-99 of the General Statutes provides that the Board of Trustees for the Connecticut State University system shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, The Student Government Association at Western Connecticut State University has requested an increase in their student activity fee to fund the cost of the student government operations, the Program Activity Counsel and other student activities, and
- WHEREAS, The management at Southern Connecticut State University has requested a new mandatory food service fee of \$250.00 per semester for residents living in Schwartz, Brownell and the North Campus Complex who are not enrolled in one of the university's meal plans, and
- WHEREAS, The net revenue from this food service fee will be used to offset operating losses attributable to the university's food service cost center, therefore be it
- RESOLVED, That Board Resolution 93-87 is amended and effective for FY1994-95 the rates for Western Connecticut State University Student Activity Fee for full-time undergraduate and graduate students will increase from \$75.50 to \$100.00 and \$70.50 to \$95.00 respectively (see attached schedule), and be it further
- RESOLVED, That effective for FY1994-95 Southern Connecticut State University shall charge a mandatory food service fee of \$250.00 per semester to residents of Schwartz, Brownell and the North Campus Complex residence halls who are not already enrolled in one of the university's regular meal plans; such fee shall provide a credit to be used for food purchases in the campus food service facilities.
