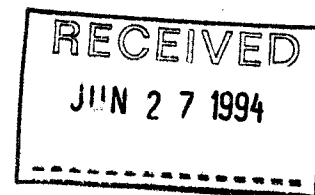
SUBJECT: Cash Gifts in Excess of \$1,000.00
