## RESOLUTION

concerning

### FEE INCREASES FOR CONNECTICUT STATE UNIVERSITY STUDENTS TIER I

April 7, 1995


- WHEREAS, Section 10a-99 of the general statutes provides that the Board of Trustees for the Connecticut State University system, shall fix fees for such purposes as the Board of Trustees deems necessary, and
- WHEREAS, Congress enacted Title IX of the Education Amendments of 1972 which provides in part that: "No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving federal financial assistance...", and
- WHEREAS, Eastern, Southern and Western Connecticut State Universities have determined, after a review of their respective athletic programs, that it would be in their best interest to be proactive in responding to the requirements of Title IX, and
- WHEREAS, Each university has developed a plan to come into compliance with Title IX standards to be implemented over three years, and
- WHEREAS, Eastern, Southern and Western Connecticut State Universities have indicated that their current revenue base is not sufficient to begin new women's sports programs called for in their plan, and
- WHEREAS, Eastern, Southern and Western Connecticut State Universities requested that the Board authorize them to increase the University General Fee for full-time students attending the University in FY1995-96, and
- WHEREAS, The Student Government Association at Central Connecticut State University has requested an increase in their student activity fee to defray the cost of membership in the Student Fitness Center and to provide increased funds to support campus clubs' and organizations' programs, therefore be it
- RESOLVED, That Eastern Connecticut State University's University General fee for FY1995-96 be increased by an additional \$20.00 per year over the increase approved by the Board in December 1994 to support the initiation of a women's lacrosse program in FY1995-96 (see attached schedule), and be it further

RESOLVED, That Southern Connecticut State University's University General fee for FY1995-96 be increased by an additional \$12.00 per year over the increase approved by the Board in December 1994 to support the initiation of women's soccer and golf programs, reinstate a women's tennis program, and expand existing programs in softball, basketball, swimming, and field hockey in FY1995-96 (see attached schedule), and be it further

RESOLVED, That Western Connecticut State University's University General fee for FY1995-96 be increased by an additional \$10.00 per year over the increase approved by the Board in December 1994 to support the initiation of a women's swimming program in FY1995-96 (see attached schedule), and be it further

RESOLVED, That Central Connecticut State University's Student Activity fee for FY1995-96 for full-time undergraduate students be increased by \$8.00 from \$86.00 to \$94.00 (see attached schedule).
