BACKGROUND

The general policy of the Board is that buildings or other physical facilities may be named in memory of those who have made significant contributions to the society or the university, or to honor people upon retirement or after retirement from active state, civic or public service.

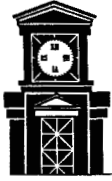
ANALYSIS

The President of Eastern Connecticut State University has submitted his recommendation for the naming of the Classroom Building in honor of Charles R. Webb. Dr. Webb was president of Eastern for eighteen years and during his tenure saw a substantial increase in enrollment, reorganized the Academic structure of the institution by establishing the Schools of Arts and Sciences, Professional Studies and Continuing Education, and guided the physical expansion of the campus from 16 to 28 buildings.

Dr. Webb was nominated for this honor by the Eastern Building and Facilities Naming Committee.

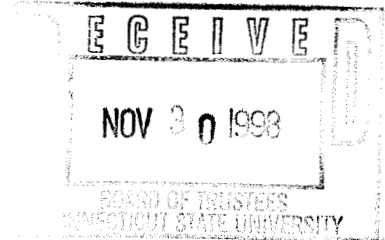
