President Pro Tempore, Connecticut State Senate

Since election as President Pro Tempore on July 1, 2004, my responsibilities have included:

- Managing staff, schedule and policy agenda for state senators
- Providing direct oversight of caucus staff
- Overseeing employment policy and protocol for all non-partisan staff in the Connecticut Legislature (1993-2014 as state senator; 2004 to 2014 as state senator and president of the senate)

Director of Development, Connecticut Bar Association

- Responsible for developing curriculum protocols and recruiting faculty for full schedule of legal seminars during each fall and spring
- Organized multi-day institute programs focusing on trial practice and appellate advocacy
