Dear members of the search committee,

It is with great anticipation that I submit to you for consideration my application to serve Northwestern Connecticut Community College as its next president. I am most grateful to Dr. Cathryn Addy for her nomination and support of my candidacy for this position. I have served in the Connecticut Community College system now the Connecticut State Colleges and University System for the past nine years, and I have witnessed a great deal of change over that time, and I am excited to see that with these considerable changes comes both opportunity and challenge.

I hope to demonstrate to you, the search committee, and the college community my experience, my strengths and my passion for community colleges and ask you to assess whether my background is suitable to be Northwestern Connecticut Community College's next president.

My entire career has led me to this point. After 19 years in higher education overall: seven years as a full time faculty member at the University of Hartford, three years as an I.T. director at Long Island University, three years as academic division director of business and technologies at Manchester Community College (MCC) and six years as dean of academic affairs at Tunxis Community College (TXCC), I am ready for the next major step in my career.

On a personal level, I am a first-generation college graduate, who grew up in a very working class background in the U.K., and attended colleges and universities not dissimilar to those in the CSCU system. I have come to appreciate the challenges that community college students face here in our state. I have chosen to commit myself and my career to strengthening the educational opportunities for Connecticut's community college students, both present and future and to do everything that I can to assure that those opportunities continue to exist.

As you will see, my background is well suited to the particular aspects that make Northwestern unique in Connecticut. I have lived in the northern part of the state for the past 9 years, and have a strong commitment to this part of Connecticut, and to continuing to provide a high quality education to the students of the northwest region. I am applying to Northwestern because of the close-knit, family-like community essential in a small college, the wide array of programs that you offer and the location in what is for me the most beautiful part of the state.

I will try to address as many of the posted expectations of this position as I can below.

Leadership

In my current role, I have been able to develop and provide leadership both within the campus and across the system in a number of ways. On campus at Tunxis I am responsible for playing a leading role in virtually all of the college's major initiatives, including our response to PA 12-40 and developmental education reform, transfer articulation, student success, program and faculty development and technology transformation at the college. As a former faculty member and professional staff member I understand the importance of cultivating a strong sense of shared governance, building buy-in and respecting the close ties that exist between the members of the campus community.

Relationship Building

I recognize that developing strong relationships, built on mutual respect and trust are critically important for any president to have. At my own campus I believe that I have earned that respect by always being fair and consistent, communicating clearly and by always being open-minded and having a willingness to listen. At the state level, I have actively sought to develop strong relationships with all of my colleagues within the CSCU system, including all of the 17 presidents, deans, vice-presidents and system office staff. In the community, it is essential for a president to be engaged with many different community groups, and I would be eager to serve on the local chamber and hospital boards and remain attentive to the needs of the local community.

Fundraising and Financial Experience

As you can see below, I have engaged in a number of focus areas that have generated resources for both the college and the system as a whole. I have been very successful in bringing in much needed resources and for advocating for our students. It would be essential for the president to make clear to all stakeholders the importance of having a community college in the northwestern region and how having that college can be used to improve both the educational and workforce outlook for the community, and thereby improve the economy of the region. In order for the college to succeed in that mission it will need support from the community in both time and money, to develop the kind of programs that the community needs. I see that as the most essential focus area for any president at this point in time.

Program Development

Like Northwestern, Tunxis CC has a mostly liberal arts focus but also provides much needed workforce development programs, especially in allied health. I oversee the allied health programs, specifically dental hygiene and dental assisting and our very important partnerships with UConn Health Center. I understand the complexities of running a clinical allied health program, which would serve me well supporting and advocating for the accelerated nursing program and veterinary programs at Northwestern. Recognizing the importance to the community of the dual nature of our mission in educational programs is critically important.

Some examples of my leadership that has fostered relationships with the community and generated funds for college initiatives include:

- Developed strong partnerships with five area high schools around Tunxis, in which we are aligning our curriculum in English and math with 12th grade curriculum, such that students can by-pass placement testing in many cases. Bridges B Grant provided \$40,000 each year of funding in 2013, 2014 and 2015 to support our work with New Britain High School.
- Led the acquisition of a \$217,000 College Access Challenge Grant for all 12 CT community colleges to develop and implement developmental education reform in 2012-2013
- Co-chaired the development of a 17 institution common academic calendar that will begin in the fall 2015 semester
- Led the effort to create a reverse transfer agreement for the CSCU system whereby students who transfer from a community college to a CSCU university can still earn their associates degree
- Served on the Greater Manchester Chamber of Commerce and regional economic development forum to promote business development
- Partnered with the U.S. small business administration to offer workshops to local businesses and entrepreneurs in the Eastern Connecticut region
- Partnered with the U.S. Transportation Security Administration from 2012-2014 to develop a certificate in Homeland Security specifically for TSA agents at Bradley Airport and for students on campus
- Guided the alignment of the learning outcomes assessment process at the college with the CSCU
 Transfer Articulation competencies and articulation of programs being developed across the
 system
- Actively leading the promotion of a student success agenda within the 12 community colleges in partnership with the Kresge Foundation funded Student Success Center, looking at guided pathways models for student completion

As you can see from the examples shared above, I have a very energetic and collaborative style that works well within the CSCU system and I know how to get things done. It is essential to develop strong relationships with many stakeholders and be engaged at all levels of the system, but also to be accessible on campus and within the community. Above all, I value the importance of being a good listener and a strong communicator.

I hope that I have been able to share with you the many accomplishments in my career and my preparation for this position, and I would be delighted to expand on any of these areas should I be fortunate enough to be invited for an interview.
